Preamble

Centre for Police Research Pashan Road Pune 411008, hereinafter referred as "CPR Pune" is a trust rregistered under Societies Act. vide government resolution in the year 1992. The CPR, Pune is an institute of national importance that imparts carriers out applied research in the fields of police working, police organization and police related issues. The Centre for Police Research plans, promotes and provides education / training in leadership, security, policy, planning and management areas. The CPR Pune organizes workshops, seminars and conferences, exhibition on subjects of policing and security.

AND

P. R. Patil College of Architecture, Amravati.

Therefore **P. R. Patil College of Architecture, Amravati.** and CPR recognized that mutual collaboration, given each other's strength in research and facilities thereof, will mutually benefit the students and facilities of CPR and the **P. R. Patil College of Architecture, Amravati.**

Now there for the parties hereto have agreed to enter into a Memorandum of Understanding (MOU) considering the long term benefit of sharing the knowledge between the institutes and established a vibrant academic collaboration, by undertaking joint activities in their respective fields of research, as below

(Hereinafter referred to as "|Activities")

It is mutually agreed by and between the parties as under.

Article 1: Objectives

The objectives of this MOU are:

- a) To allow the parties to plan collaborative research, educational, and training activities of mutual interest.
- b) To make available to the police, public, other researchers and faculty those facts, methods and new findings that are discovered through that research, and to share specialized scientific equipment, physical facilities and support services in ways that will expand and provide more cost effective research and education for the Parties.

Article2: Activities

- a) Seek mutual advice and support in planning and executing programs promoting excellence in respective areas of research and education.
- b) Encourage the regular / visiting faculty members and scientist, of either Institute to visits the other institute for giving talks in lecture / programs.
- c) Encourage students / research personnel/ staff of either institute to attend lectures, seminars, workshops and conference in the respective areas of interest.
- d) Share the library and scientific lecture and facility mutually by giving access to library and resources of either institute to the scientist/ students / research personnel of other institute.
- e) Encourage the research fellow, staff or students to visits the other institute for short duration for gating research inputs and guidance upon recommendation from the CPR or P. R. Patil College of Architecture, Amravati.
- f) Encourage joint research activities and project. Interested faculty of either institution may initiate joint research projects. Subject to available funding, the Parties will encourage research centers of their respective institutions to initiate and conduct collaborative projects consistent with the other terms and specifications of this agreement. Such joint research projects are to be the subject of definitive project agreements specific to each project and separatefrom this MOU.

Article3: Coordinating Committee

There will be a co-coordinating committee consisting of the SP of CPR, Pune and P. R. Patil College of Architecture, Amravati. and if necessary, to additional member from each institute who will be responsible for the effective implementation of the MOU.

a) If any charges / expenses are to be paid by either institute for the facilities provide by the other institute, such will be decide by co-coordinating committee by a separate 'Rentals and Services Agreement 'which also may be modified from time to time as per the need.

Article4: Disclosure, Publicity and Use of Names and Trademarks

CPR Pune and - P. R. Patil College of Architecture, Amravati. shall, on their respective website and business communication, make a mention of this RESEARCH, EDUCATION & TRAININGPARTNERSHIP AND COLLABORATION. Any referred communications will be sent for review and approval by the co-ordination committee.

- a) The Parties acknowledge that by entering into this MOU is neither stating nor implying that it has tested, endorsed or approval any research, service or training.
- b) Nothing in this Article is intended to restrict either Party from disclosing the existence of any nature of this MOU or from including the existence of and nature of this MOU in the routine reporting of its activities.

Article5: Secrecy

Confidential information shall be exchanged only under the terms of a separate agreement, whether a non-disclosure agreement, sponsored research agreement, material transfer agreement, or data use agreement. No confidential information shall be disclosed pursuant to this MOU.

Article6: General Terms

- a) This MOU is effective from the date when both parties have signed it ("Effective Date").
- b) The MOU may be amended or extended by mutual consent in writing signed by authorized representatives of the Parties.
- c) Each party is liable for its own acts and omissions under this MOU, which, for the prevention of doubt, does not include any liability based on the acts or omissions of a third party.
- d) No export-controlled information shall be disclosed pursuant to this MOU.
- e) This MOU may be executed in counterparts, which taken together will constitute one document.

Article7: Duration

This MOU shall remain in force for a period of five (5) years from the Effective Date. Either Party may terminate the MOU by providing at 30 days' advance written notice to the other Party. Termination or expiration of this MOU does not automatically terminate any separate agreement between the Parties related to the subject matter of this MOU.

Article 8: Intellectual Property, Inventions and Innovations

a) The terms with respect to title to and exploitation of intellectual property (including trademarks and service marks, copyrights, patents designs and confidential information the subject of such intellectual property, inventions and innovations) will be negotiated on a project-by-project basis in the specific research project agreements and broadly governed by the IPR policy of both institutions.

b) Information on research results and scientific materials (reports, articles, books) will be exchanged freely keeping in mind the mutually agreed

provision of Intellectual PropertyRights.

All Intellectual Property solely conceived and/or developed by CPR Pune during thecourse of this Agreement shall be owned by CPR Pune. All Intellectual Property solelyconceived and/or developed by during the course of this Agreement shall be owned by P. R. Patil College of Architecture, Amravati. Intellectual Property jointly conceived and/or developed by CPR Pune andWillbe jointly owned by CPR Pune and P. R. Patil College of Architecture, Amravati.

Article 9: Governing Law

The contract shall be govern by the law of India for the time being in force.

Article10: Authorized Signatories

Each institution represents that the individuals signing this MOU have theauthority to sign in the capacity indicated.

This MoU is signed subject to approval by the appropriate authorities on both sides.



Process of patenting your invention:

For the purpose of filing of patent application standard procedure which we follow is as under:

Prior art search:

Before starting the process of drafting of patent application we have to conduct prior art search of the invention for assessment of patentability of the invention which takes 8 working days.

Basic prior art search:

This is the standard form of prior art search which is conducted before starting the process of drafting of patent application. In this search we use free to use search engines and if any similar art is observed it is forwarded to you and inventor has to assess whether he wishes to proceed for drafting of patent application.

Patent application Drafting:

After completion of search we start the process of drafting of patent application. For this purpose we need information in a standard format which will be provided to inventors. In this part we draft the patent application according to the standard legal format and forward it to you for your approval. This process takes 9 working days. Once invention is approved by you or after making relevant modifications suggested by you we proceed for filing of patent application.

Patent application filing:

After final draft is ready we proceed for filing of patent application which is normally filed online after taking your signature on the application. This ordinarily takes 3 working days.

Publication of patent application:

After filing of patent application at Indian patent office it is published in patent journal after 18 months of filing. International patent filing:

These applications can be filed after 6 weeks of filing of Indian patent application and within one year of the said filing. After 1 year of Indian application filing we cannot file patent application outside India.

MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN

This MOU is entered into on the 9th day of August 2019 by and between G. H. Raisoni College of Engineering Nagpur(hereinafter called GHRCE) located at Digdoh Hills, MIDC Area, Hingna Road, Nagpur-16 and P.R. Patil College of Architecture, (hereinafter called Mentee Institute), an Architecture, collegeKathora Road, Amravati.

The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes.

1. Preamble

As a part of the Quality Mandate, University Grants Commission (UGC) has set the goal to get every Higher Education Institution (HEI) accredited. In order to achieve this goal, UGC has introduced a new scheme 'PARAMARSH' with the main objective of the scheme is to enhance the overall quality of the Mentee institutions by mentoring the Non-Accredited Higher Education Institutions to enable them to getaccredited.

The Scheme will be operationalized through a *Hub & Spoke* (H&S) Model where the Mentor Institution, called the hub is centralized and will have the responsibility of guiding the Mentee institution through the secondary branches, the spokes which are the additional services provided to the mentee for self-improvement. Mentoring shall be imparted through the Internal Quality Assurance Cell (IQAC) of the Mentor Institutions, which shall be primarily responsible for the implementation of the program. The Mentee institutions shall be consulted first to obtain their readinessto—take upthementorship of mentor Institution. The participating institutions are required to nominate fulltime faculty members as the Coordinator of the project.

2. Objectives of the MOU

The aim of this MoU is to enhance the overall quality of the mentee institutions and to enable them to get NAAC Accredited

The objectives of the MOU are:

- To conduct Training of Faculty and Staff for proper processes, documentation, presentation
- To Share knowledge, information and resources to mentee Institution.
- To support for research collaboration, faculty development& Opportunities
- To give guidance and encouragement to institutions to adopt best practices.

3. Duration

This MOU shall remain effective from the date of execution until the end of the term of one (01) year which can be extended up to two years and shall remain in force till the duration of the scheme-UGCParamarsh.

4. Terms and Conditions

- The activities under this program shall be conducted either at GHRCE orP.R.Patil
 College of Architecture, Kathora Road, Amravati
- No financial assistance is required from Mentee Institution but shall make available the required Facilities and manpower for the conduction of the activities.
- The participating (Mentee) institutions are required to nominate fulltime faculty members (one from each participating institutions) as the Coordinator of the project
